AGREEMENT

In consideration of Van's Nursery, Inc. (referred herein as "Van's") extending credit to Applicant, Applicant agrees to pay for all items delivered to or at the request of Applicant by the 25th of the month following purchase. The applicable cash discount may be taken if Van's' invoice(s) is paid no later than the 10th of the month following purchase. All accounts are due and payable at the remittance address shown on the Van's invoice. Applicant agrees that each of the terms and conditions of sale stated on the Van's invoices shall be a term of contract of each sale from Van's to Applicant. Applicant acknowledges that a monthly service charge will be made on all sums due to Van's which have not been paid within thirty (30) days from the invoice date, and Applicant agrees to promptly pay said service charge. The service charge shall be 1.5% per month, but not to exceed the highest amount lawfully allowed by contract in the state in which this application is executed; it shall be made on the thirty-first (31st) day after the original invoice date; and an additional service charge, computed on the same basis, shall be made every thirty (30) days thereafter. If Van's receives as a service charge an amount in excess of said highest amount lawfully allowed by contract, such excess amount shall be applied to the reduction of the unbpaid balance due and shall not be treated as a service charge. Waiver of any one or more service charges shall not be deemed a waiver of any future charges. Applicant further agrees that with regard to such service charge, Applicant and Van's are parties to a written contract. If Van's commences litigation or employs attorneys in order to secure payment of any sums due to it from Applicant, the Applicant agrees to pay a reasonable attorney's fee in addition to all other sums due. Applicant agrees to notify Van's in writing of any change in ownership or status of ownership and further agrees that all chargers incurred will remain the responsibility of Applicant unless agreed by Van's in writing. The Applicant authorizes Van's to obtain credit and financial information concerning the Applicant at any time and from any source.
